Subj: GUIDELINES FOR FUNDRAISING ACTIVITIES

1. Purpose. To provide guidelines concerning the conduct of fundraising activities on board U.S. Naval Support Activity, (NAVSUPPACT), Naples, Italy by command-recognized private organizations, student activity funds, unit recreation committees, youth activity programs, other non-appropriated fund activities and non-federal entities.

2. Scope.

a. This instruction applies to:

(1) All private organizations seeking to fundraise on NAVSUPPACT Naples in accordance with references (a) and (b);

(2) Student Activity Funds (SAFs) seeking to fundraise on NAVSUPPACT Naples in accordance with reference (c);

(3) Tenant command unit recreation committees seeking to fundraise on NAVSUPPACT Naples to supplement Morale, Welfare and Recreation (MWR) unit recreation funds in accordance with reference (d);

(4) Youth activity programs organized by the Director of MWR seeking to fundraise on NAVSUPPACT Naples in accordance with references (e) and (f); and

(5) Other non-federal entities and activities seeking to fundraise on NAVSUPPACT Naples in accordance with appropriate authority.

b. This instruction does not apply to Department of Defense Dependents Schools-Europe (DoDDS-E), student body activities that are conducted during the academic day on school grounds as an adjunct of the academic program.

### 3. Definitions.

a. A non-federal entity is defined in reference (g) as a self-sustaining, non-federal person or organization, established, operated and controlled by any individual(s) acting outside the scope of any official capacity as officers, employees or agents of the Federal Government.

b. A private organization is defined in reference (a) as a self-sustaining and non-federal entity, incorporated or unincorporated, which operates on Department of Defense (DoD) installations with the written consent of the Installation Commander or higher authority, by individuals acting exclusively outside the scope of any official capacity as officers, employees, or agents of the Federal Government.

c. Student Activity Funds (SAFs) are those programs established and conducted under reference (b).

d. Unit recreation committees are those groups, governed by reference (c), which are established by Commanding Officers or Officers in Charge of Tenant Commands for the purpose of utilizing unit recreation funds (URFs) allocated to their commands by MWR, and for raising additional funds to supplement these URFs.

e. For the purpose of this instruction, youth activity programs are those programs established and conducted under references (d) and (e).

4. Policy.

a. Fundraisers and/or large events shall not be conducted on board NAVSUPPACT Naples without prior written approval from the Commanding Officer, NAVSUPPACT Naples via the NAVSUPPACT Naples Staff Judge Advocate (SJA). Additionally, major events having a significant impact on the routine operations of the installation will require approval from the NAVSUPPACT Naples Executive Officer.

b. NAVSUPPACT Naples may limit the number of fundraisers, meetings, and events or activities that an organization may conduct on the installation to ensure equitable treatment of various groups.

c. When conducting fundraisers or activities on the installation, organizations and their members shall comply with all applicable U.S. Naval Hospital, Naples, Italy Preventative Medicine Department requirements including food-handling rules.

d. All organizations and their members shall comply with all requirements of the NAVSUPPACT Naples Fire and Emergency Services, the NAVSUPPACT Naples Security Department and the NAVSUPPACT Naples Safety Office when conducting fundraisers or activities on the installation.

e. When specifically authorized in writing, organizations may offer programs, services, or products that complement either appropriated or non-appropriated fund activities on NAVSUPPACT Naples, but they shall not compete with such DoD programs.

f. A copy of the approved Fund Raiser Request Form must be available for presentation during all fundraiser events.

5. Procedures.

a. As noted above, regulatory guidance for fundraising varies depending on an organization's status. Organizations seeking to fundraise on NAVSUPPACT Naples shall complete the applicable activity request forms provided in enclosures (1) and (2). Activity request forms should be submitted to NAVSUPPACT

Naples SJA no fewer than seven working days prior to the requested event. Advance planning is encouraged, as NAVSUPPACT

b. Prior to approving a private organization's request, a check will be conducted to ensure all command recognition data is current (see reference (f), paragraph 8a).

c. Organizations will receive a written approval or denial of their requests. Organizations should bear in mind that the Commanding Officer, NAVSUPPACT Naples, Italy reserves the right to withdraw any approval or modify fundraisers at any time.
