1. Purpose. To set forth policies and regulations governing the operations of the Naval Support Activity (NAVSUPPACT), Naples, Italy, Auto Skills Center.

2. Cancellation. NAVSUPPACT NAPLES INST 1710.6E.

3. Information

a. The NAVSUPPACT Naples Auto Skills Center is operated under the cognizance of the NAVSUPPACT Naples, Morale, Welfare and Recreation Director. Eligible patrons are listed in references (a) and (b).

b. The Auto Skills Center provides services and facilities for minor repairs and cleaning of privately-owned motor vehicles.

4. Regulations

a. Auto Repair

(1) All work will be self-service. Use of the facility to repair vehicles for personal gain is prohibited.

(2) Vehicles may not remain in the shop overnight except in unusual cases, and then only with permission of the facility manager, and at a set fee.

(3) Patrons are not authorized to check-out or rent tools to be used outside of the Auto Wood Skills Center.

(4) Vehicles must be checked in and out by facility attendant.

(5) Patrons using stalls will be responsible for cleaning the area prior to securing.


(6) Patrons not compliant with the above regulations may be denied further use of the facility.

b. Car Care Equipment

(1) All Car Care Equipment (vacuum cleaners, hand-held pressure spray and automatic car washer) require the chip card for operations. Chip cards are available for purchase at the facility's customer service counter or from the self-service machine located near the car wash.

(2) Patrons are required to follow the operating instructions posted for each piece of equipment.

(3) Patrons not in compliance with the above regulations may be denied further use of the equipment and facility.
