1. Credible evidence has been presented to the Okinawa Armed Forces Disciplinary Control Board that the establishments specified in paragraph two are engaged in the sale of prohibited substances; promote the exploitation of children; or promote human trafficking and exploitation of women and thereby constitute a threat to the health, safety, and good order and discipline of our military and civilian communities.

2. Per reference (a) the following establishments are off-limits to all military personnel, government civilians, authorized dependents and contractors covered under the U.S./Japan Status of Forces Agreement.

- a. Samurai King, 1-8-1 Chuo, Okinawa City.
- b. Stoner's Den, 2-17-1 Makishi, Naha City.
- c. Ground Tobacco Shop, 2F 1-5-9 Mihama, Chatan-Cho.
- d. Jah Reggae Shop Okinawa, 1-6-20, Chuo, Okinawa City.
- e. Bon Bon Dou, 1-9-8, Uechi, Okinawa City.
- f. Bar Sakura, 1-10-15, Chuo, Okinawa City.
- g. Tokyo Syoten Bookstore, Highway 23 at 820-6 Kamisedo, Chatan-Cho.
- h. Yasu Ichi Bookstore, 2-1-10 Chatan.

- i. AMS, 2-12-21 Maejima, Naha City.
  - j. Butterfly, 1-12-13 Tsuji, Naha City.
  - k. High Times, 1-6-2 Chou, Okinawa City.

  - m. Soft Cream, 1-15-8, Okinawa City.

3. This order is punitive and will remain in effect until revoked or modified under my authority. Penalties for violation of this order include the full range of statutory and regulatory sanctions for military and civilian personnel, to include adverse administrative action or trial by court-martial.
