<b>Process Specific - Shop/Work Center Supervisor</b>								
- complete annual ECATTS on-line training module "Stormwater - Basic Information (~20 min)" or "Stormwater - Comprehensive Overview (~20 min)" or by obtaining Storm Water Pollution Prevention training video from PWD Environmental Division and maintain training log of viewing for record of completion. Completes other site specific stormwater training if determined necessary by the EV media program manager.								
- complete annual ECATTS on-line training modules "Spill Prevention Control and Countermeasures (~20 min)" , "Petroleum, Oils, and Lubricants Management (~10 min)" and "Storage Tank Management (~15 min)", if you maintain and/or operate an oil and hazardous substance storage tank. Completes site specific SPCC training if determined necessary by the EV media program manager.								
- complete annual ECATTS on-line training module "Hazardous Waste Management (~20 min)" if shop/work center uses hazardous material in its work processes and has potential to generator hazardous waste. Completes site specific hazardous waste management training if deemed necessary by the EV media program manager.
